Dear Mr. Wheelock:

The U.S. Army Corps of Engineers (Corps) received your request for a determination as to whether the property located within Enchanted Lakes (TMK 4-2-83:74 &75) in Kailua, Oahu, Hawaii may be jurisdictional. Your request has been assigned Corps No. POH-2010-00038. Please refer to this number in all correspondence.

The project area reviewed by the Corps, and addressed in this letter and accompanying documentation, is shown on Enclosure 1 (labeled Figure 8).

The Corps has determined the wetlands and other waters shown in Figures 7 are jurisdictional waters of the United States. A total of 0.024 acres of wetlands will be regulated as "waters of the United States." The placement of dredged or fill material into these waters may require a Department of the Army permit under our regulatory authorities found in Section 404 of the Clean Water Act

Enclosure 2 is the jurisdictional determination that identifies the basis for asserting jurisdiction. If you are not in agreement with that approved JD, you can make an administrative appeal under 33 CFR 331. Please see the enclosed Notification of Administrative Appeal Options and Process and Request for Appeal for further information about that process (Enclosure 3). This approved JD is valid for five years from the date of this letter unless new information warrants revision of the determination.

In addition, the Corps has closed the previous "unauthorized activity" action associated with the POH-2010-00038 file number.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
